 - g. Richard Heath, CPA for April 30, 2015.



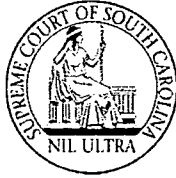
