COMES NOW Betty Fisher, Appellant in the above appeal, and, pursuant to Rule 263(b),
SCACR, moves for a 30 day extension of time to file her Initial Brief of Appellant and
Designation of Matters to be Included in the Record.

By Order entered January 6, 2015 the time for filing Appellant's initial brief and designation of matter was extended until February 6, 2015. On January 27, 2015 Appellant moved to consolidate the appellate record in this and in two related appeals, to allow filing of a reduced number of copies of the record, and to allow 30 days to file briefs and designations after a ruling on said motion.

On March 9, 2015 counsel for Appellant was informed that the Court had granted the motion to consolidate the appellate record, and to allow filing of a reduced number of copies of the record. Counsel for Appellant was informed that the Court did not grant or deny the request for 30 days to file briefs and designations. This is Appellant's second extension request, and an extension is needed due to simple fact that until the Court's ruling upon the motion to consolidate, Appellant could not know whether to file separate designations of matter for each of the three related appeals or whether to file a consolidated designation of matter. Due to the work schedules of counsel and co-counsel, Appellant moves for an extension of 30 days in which to file Appellant's initial brief and consolidated designation.

WHEREFORE, Appellant prays for an Order granting a 30 day extension of time to file Initial Brief of Appellant and Consolidated Designation of Matter to be Included in the Record.

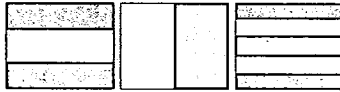
