Respondent through his undersigned counsel, would respectfully show unto this Court as follows:


I.



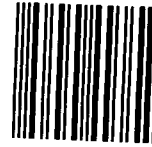
