I received a letter dated January 15, 2015 which instructed me that I am given forty-five (45) days from the date of the letter to submit a pro se brief addressing any issues I believe the Court should consider in this appeal.

I thank you for given me an opportunity to address the Court of Appeals with pro se issues but I have a serious concern that is obstructing my direct appeal rights. this why I pen you this letter I am in receipt of my Record on Appeal from the Appellate Defense this record contains the transcript of my trial from July 16-17, 2013 but it entirely excludes the evidence hearing / ~~suppression~~ suppression hearing held on September 2012. The September 2012 evidence hearing / suppression hearing transcript contains contemporaneously objected to and preserved direct

Appeal issue concerning Confrontation Clause Violations. Bigger identification violations S.C. Rules of Evidence hearsay and authentication violations, due process violations and the immunity under the Protection of Person's and Property Act regarding testimonial evidence of the State witnesses, and other evidence. It is imperative that I receive this September 2012 transcript to effectively exercise my direct appeal right in accordance to due process.
