MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for Tykeem May respectfully requests a **fourth and final** extension of thirty (30) days **until May 6, 2015**, in which to file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The initial brief of appellant and designation of matter are due to be filed with the Court today. The Court has granted counsel three previous extensions.



Dudek, counsel filed a Petition for Extraordinary Relief in the Supreme Court in the capital case of Marion Alexander Lindsey v. State. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Quinton Dewayne Inman v. State of South Carolina with the Supreme Court on February 13, 2015. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Robert Wilson Woods with this Court on February 12, 2015. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Edgar B. Merrifield with this Court on February 9, 2015. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Jimmy Turner with this Court on February 5, 2015.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

5. Counsel for the Attorney General's office consents to this request shown by signature below.






