Dear Ms. Kitchings:

It is indicated that my clients Southern Holdings and the Estate of Doris Holt, are not listed as Respondents in the above captioned case before the Appellate Court. I respectfully request that that be corrected. Both clients were named as parties in the underlying legal malpractice action. In the Final Order Judge Addy named both Southern Holdings and the Estate of Doris Holt as parties to his order in this matter.

James Spencer, *Pro Se*, the council for John Rakowsky, and the council for Adrian Falgione have chosen to leave Southern Holdings and the Estate of Doris Holt out of the caption, but that is not correct. Appellant Spencer did serve his Notice of Appeal on me as counsel for Southern Holdings and the Estate of Doris Holt.

In short, Southern Holdings and the Estate of Doris Holt are named parties to this appeal. Southern Holdings and the Estate of Doris Holt have not been dismissed in the lower court and both remain a party; they have not been dismissed. Both clients have a financial interest in this appeal. I would therefore ask the Court to correct its records to identify Southern Holdings and the Estate of Doris Holt as Respondents and to require the caption to include all parties from the action.

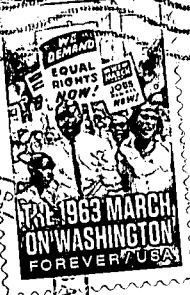
