
INDICTMENT FOR
POSSESSION OF MARIJUANA WITH INTENT
TO DISTRIBUTE

§ 44-53-0370(b)(2)

At a Court of General Sessions, convened on AUGUST 2014, the Grand Jurors of Lexington County present upon their oath:

That **Matthew Antwon Gunter** did in Lexington County, South Carolina on or about May 11, 2014, knowingly, intentionally, willfully, and unlawfully possess with intent to distribute Marijuana, a Schedule I(d) controlled substance under the provisions of § 44-53-190 et. Seq. and, in violation of § 44-53-370(b)(2), Code of Laws of South Carolina, 1976, as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
