This is in reply to your correspondence to the The Department. We apologize for the delay of this response.

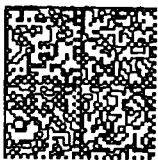

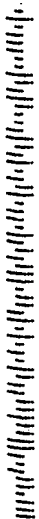
