Dear Chief Justice Jean Toal,
My name is Tyrone Lorenza Robinson. I was represented by the Beaufort County Public Defender Office by Attorney Arie David Bax. I went to trial in Beaufort County General Session Court on September 15th 2014 on Indictment # 2012-65-07-1935.

I was facing a life sentence during trial my attorney specifically told me that if the jury found me guilty he was going to file me an appeal and my attorney reserved some issues he said he was going to appeal. Unfortunately the jury found me guilty on an unindicted charge on September 19th 2014. For some reason I had a feeling my attorney may not file my notice of appeal and proper paper work with the South Carolina Appeals Court and the Division of Indigent Defense and Attorney General. So on September 24th, 2014 I timely filed a notice of appeal with certificate of service to South Carolina Appeals Court, the Division of Appellate Defense and Attorney General office. I also filed a motion to be appointed counsel to represent me on my appeal then I later filed another motion to be appointed an attorney from the Division of Indigent Defense to represent me on appeal and I filed a motion to proceed on appeal in forma pauperis. It has been 6 months and I have not heard anything from an attorney or the Appeals Court, I have wrote the Clerk of Court at South Carolina Court of Appeals whos name is Jenny Abbott Kitchings however for some reason the Clerk of Court at South Carolina Appeals Court will not respond to me, to inform me if my appeal case is on file pending at South Carolina Court of Appeals or not, or if I have been appointed an attorney to represent me on my appeal if any yet. I also have not been notified of the name address and telephone number of the attorney who is assigned to represent me on appeal if any. However it is obvious my attorney Arie David Bax failure to file my notice of appeal and failure to submit to required paper work to the Division of Indigent Defense to obtain me proper representation for my appeal has contributed to this. I ask this court to please contact public defender Arie David Bax and order him to fulfill his duty and file the proper paper work on my behalf A.S.A.P with

THE SOUTH CAROLINA COURT OF APPEALS, THE DIVISION OF INDIGENT DEFENSE AND THE ATTORNEY GENERAL OFFICE, TO INSURE THAT MY APPEAL IN MY CRIMINAL CASE IS PROPERLY FORMED AND SUBMITTED PROPERLY FOR REVIEW ON MY BEHALF AT SOUTH CAROLINA COURT OF APPEALS, AND ALSO TO INSURE THAT I RECEIVE PROPER REPRESENTATION OF A QUALIFIED ATTORNEY FROM THE DIVISION OF INDIGENT DEFENSE TO REPRESENT ME ON MY APPEAL CASE AND FILE MY APPEAL BRIEFS AND OBTAIN MY TRIAL TRANSCRIPT AND EVERYTHING REQUIRED IN MY APPEAL CASE. SINCE I WAS REPRESENTED AT TRIAL BY THE BEAUFORT COUNTY PUBLIC DEFENDER OFFICE

AND I AM ENTITLED TO REPRESENTATION BY THE DIVISION OF INDIGENT DEFENSE BECAUSE SO ALSO BECAUSE OF MY POVERTY AND SITUATION I AM IN WHICH I AM UNABLE TO AFFORD A PAID ATTORNEY TO REPRESENT ME ON APPEAL. I KNOW YOU ARE VERY BUSY HOWEVER TO INSURE THAT I AM NOT PREJUDICED IN MY APPEAL CASE AT SOUTH CAROLINA COURT OF APPEALS. I ASK YOU TO ORDER MY ATTORNEY ARIE DAVID BOX TO FILE THE PROPER PAPER WORK IN MY APPEAL CASE A.S.A.P. TO INSURE THAT MY APPEAL CASE IS IN PROPER FORM AND TO INSURE THAT I OBTAIN PROPER REPRESENTATION OF COUNSEL TO REPRESENT ME ON MY APPEAL, AT SOUTH CAROLINA COURT OF APPEALS. THANK YOU SINCERELY ALSO PLEASE HAVE YOUR CLERK OF COURT DANIEL F. SHEAR HOWE RESPOND TO ME A.S.A.P. TO INFORM ME IF I HAVE A APPEAL CASE PENDING AT SOUTH CAROLINA COURT OF APPEALS AND TO INFORM ME OF THE NAME AND ADDRESS AND TELEPHONE NUMBER OF THE ATTORNEY WHO HAS BEEN APPOINTED TO REPRESENT ME ON MY APPEAL IF ANY AT SOUTH CAROLINA COURT OF APPEALS.

APPEAL AND PROPER PAPER WORK WITH THE SOUTH
CAROLINA APPEALS COURT AND THE DIVISION OF INDIGENT
DEFENSE AND ATTORNEY GENERAL. SO ON SEPTEMBER
24TH, 2014 I TIMELY FILED A NOTICE OF APPEAL WITH
CERTIFICATE OF SERVICE TO SOUTH CAROLINA APPEALS
COURT, THE DIVISION OF APPELLATE DEFENSE AND ATTORNEY
GENERAL OFFICE. I ALSO FILED A MOTION TO BE APPOINTED

 A NAME, ADDRESS OR TELEPHONE NUMBER OF
 ANY ATTORNEY ASSIGNED TO REPRESENT ME
 ON APPEAL. HOWEVER IT IS OBVIOUS MY PUBLIC

 ATTORNEY REPRESENTING ME ON MY APPEAL TO
