I AM WRITING THIS LETTER, WITH INTENT TO SHOW, I WAS MISLED BY MY COUNSEL MR. CHARLES SNYDER, DECEIVED BY HIM, + COERCED BY HIM INTO TAKING A PLEA. FROM THE BEGINNING I HAD BEEN ASKING MR. SNYDER, TO EITHER HELP ME ON MY CASE OR REMOVE HIMSELF FROM MY CASE AND HAVE MY CASE PLACED IN AN ATTORNEY HAND THAT IS ABLE TO DO SO. THE OFFICER COMES TO GET ME TO COME INTO THE COURT ROOM. I'M THINKING WE'RE ABOUT TO HAVE THE HEARING AND THE OFFICER TELLS ME THAT, MR. SNYDER WAIVED YOUR HEARING AND LEFT THE COURT ROOM. I SEEM FROM THAT DAY, WE WERE NOT ON THE SAME PAGE. I THEN START TO WRITE HIM, VIA E-MAIL, FROM SPARTANBURG COUNTY DETENTION CENTER, TELLING HIM ABOUT MY CASE. HE RESPONDS WEEKS LATER SAYING, "WE WILL TALK ABOUT THINGS WHEN I COME SEE YOU", WHICH TOOK MONTHS AND THEN I HAD TO WRITE HIS BOSS CLAY ALLEN, JUST TO GET HIM TO COME SEE ME AND GO OVER MY CASE. I COULD CLEARLY SEE HE HAD NO INTEREST NOR INTENTIONS ON HELPING ME WITH MY CASE. HE HAD ALREADY FORMED AN OPINION ON MY CASE AND DECIDED I WAS GUILTY EVEN BEFORE WE ACTUALLY SAT DOWN TO TALK ABOUT MY CASE. I REQUESTED THAT HE BE REMOVED BUT MY REQUEST WAS DENIED. I EVEN WROTE TO S.C.I.D. ABOUT THE MATTER. MR. SNYDER THEN CAME TO ME AND WE SPOKE. THAT CONVERSATION WAS ABOUT ME CONTACT COLUMBIA + MR. CLAY ALLEN ABOUT HIM. HE STATED, "BY YOU CONTACTING THESE PEOPLE ABOUT ME, DOESN'T MAKE ME WANT TO WORK HARD ON YOUR CASE". I THEN WROTE TO MR. ALLEN AGAIN, TELLING HIM ABOUT THE CONVERSATION AND IT WAS IGNORED AND NOTHING DONE. I ASKED TO HAVE MR. SNYDER REMOVED SEVERAL TIMES. HOW CAN I HAVE A FAIR CHANCE AT A TRIAL OR ANYTHING, WITH AN ATTORNEY WHO REFUSES TO WORK THE CASE? I ASKED FOR AN FAST AND SPEEDY TRIAL WHICH WAS NOT DONE, I ASKED ABOUT RULE 5 + RULE 6 WHICH WAS IGNORED, I ASKED FOR ANOTHER BOND HEARING, JUST SO HE COULD ASK THE JUDGE TO SET AN DATE ON WHEN TO HAVE MY CASE HEARD. AND AGAIN MY REQUESTS WAS DENIED. SO NOW I'VE BEEN SITTING IN THE COUNTY JAIL FOR OVER AN YEAR AND CAN'T GET ANYTHING DONE. I INSIST ON HAVING A TRIAL, BUT MR. SNYDER IS AGAINST ME. HE TELLS ME, "MY WITNESSES TOLD HIM THAT THEY WOULD NOT TESTIFY" WHICH WAS A LIE. I HAD BEEN TRYING FOR MONTHS TO GET HIM TO CALL THEM + SPEAK WITH THEM. HE REFUSED TO CONTACT MY HAND DOCTOR, TO SEE WHAT TYPE OF BURN I SUSTAINED ON MY HAND + WHAT COULD HAVE CAUSED THE BURN. THAT WAS VITAL TO MY CASE. THE STATE WAS SAYING I BURNED MY

HAND STARTING A FIRE INSIDE A HOME, YET I HAD AN CONTACT BURN, MEANING, I WOULD HAVE LEFT DNA AT THE CRIME SCENE, WHICH THEY DID NOT FIND ANY OF. AGAIN, I MADE ALL THIS KNOWN TO HIM, BUT HE IGNORED THE INFORMATION. HE REFUSED TO TALK TO OR HAVE AN INVESTIGATOR TALK TO THE "EYE WITNESS" WHO IS CLEARLY LYING OR WAS TOLD WHAT TO SAY. I POINTED OUT TO MR. SNYDER, FOR ONE, NO ONE NEVER SAID THEY SEEN ME, 2.) THE ONLY WAY THE WITNESS COULD HAVE MADE THE STATEMENT 2 TIMES OF SAYING "I SEEN A GREY BUICK LESABRE, SITTING IN THE ROAD WITH NO LIGHTS, WITH A HANDICAP SIGN HANGING FROM THE MIRROR," IS IF HE WAS TOLD WHAT TO SAY OR HAD PRIOR KNOWLEDGE WHAT TO SAY. HOW CAN ANYONE TELL THE MAKE + MODEL + COLOR OF A CAR AT NIGHT THAT IS SITTING IN THE ROAD WITH NO LIGHTS ON, BUT THEY CAN'T SAY IF THE INDIVIDUAL WAS MALE OR FEMALE, WHETHER WHITE/BLACK ETC..., NOR WHAT THE PERSON HAD ON, NOR TAG NUMBER. BUT HE CAN SAY FOR CERTAIN IT WAS AN GREY BUICK LESABRE WITH A HANDICAP SIGN. I ALSO TOLD HIM, THAT IT IS 2 CARS THAT LIVE ON THAT SAME STREET, ONE OF WHICH MATCHES THAT DESCRIPTION, BUT YET AGAIN MR. SNYDER REFUSED TO LOOK INTO IT. HE EVEN TOLD ME THAT THE COLOR OF THE CAR DOESN'T MATTER. SEEING THAT I TOLD HIM, I DON'T HAVE A CAR, BUT MY FIANCE' DOES HAVE AN DARK GREEN BUICK LESABRE, WHICH WOULD NOT LOOK GREY AT NIGHT. THE REGISTRATION OF THE CAR WAS PROVIDED FOR HIM SO HE KNEW WHAT I WAS SAYING WAS THE TRUTH. I ALSO INFORMED HIM WITHIN 2 WEEKS OF ME BEING INCARCERATED THAT THE DETECTIVE (HORTON) ILLEGALLY SEARCHED THAT CAR. SEEING IT IS NOT MY CAR, NOR DID HE OBTAIN PERMISSION TO DO SO UNTIL AFTER HE HAD MY TOOK MY WALLET OUT OF THE CAR, WHICH WAS NOT IN PLAIN VIEW SIGHT. I TOLD HIM ABOUT THIS AND HE DID NOTHING OR SAID NOTHING ABOUT IT. NOW I RECEIVE NEWS OF A COURT DATE TO BE HELD ON FEB. 9th 2015. I'M PUSHING FOR TRIAL, BUT MR. SNYDER USES SCARE TACTICS BY INFORMING THAT I'M GOING TO GET LIFE IN PRISON, SO LET HIM TRY TO GET A GOOD PLEA FOR ME. I TELL HIM, "THE ONLY WAY I PLEA TO SOMETHING I DIDN'T DO IS ON MY TERMS." I HAVE THE PAPERWORK FROM OUR KIOSK SYSTEM, THAT PROVIDES PROOF OF ALL MY EMAILS BETWEEN ME + MR. CRAIG AULON AS WELL AS ME + MR. CHARLES SNYDER. I THEN WROTE TO THE DISCIPLINARY BOARD ABOUT THIS CONDUCT AND BEHAVIOR. AS OF RIGHT NOW I'M AWAITING WORD FROM THEM. AS TIME GETS CLOSER TO THE DATE, HE TELLS ME, IT WILL BE A GOOD PLEA JUDGE THERE. HE ALSO STATED THAT THE SOLICITOR IS READY TO DO A PLEA TO BURGLARY 2ND, WE DISCUSS ALL THIS FACE TO FACE BEFORE ENTERING THE COURT ROOM. HE WAS GOING TO RECOMMEND 5YRS SUSPENDED TO 3YRS A.T.U.

WHICH WOULD BASICALLY GIVE ME TIME SERVED. THAT OF COURSE DID NOT HAPPEN. IN FRONT OF THE JUDGE, HE SAID NOTHING TO THAT AFFECT. HE THEN TELLS ME NOT TO GO AGAINST WHAT THE PROSECUTION WAS SAYING, JUST AGREE TO IT. I ASK HIM "WHAT SHOULD I SAY IF THE JUDGE ASKS ME WHAT TOOK PLACE?" HE RESPONDED SAYING "I DON'T KNOW MAKE UP SOMETHING". 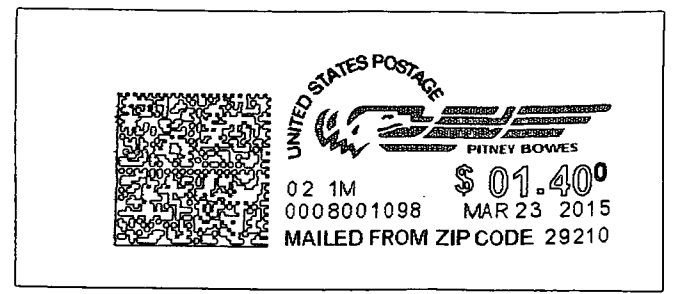
