To whom this may concern,

My name is Anthony Marklak Perferleff Jr. and I went to trial on the 23rd of February, found guilty on the 27th of February and sentenced to 30 years in prison on the 6th of March. I was represented by Anastasia Walker from the Public Defender's Office. I was told by her I will be appointed to an appellate attorney but considering all the things she did and didn't do in my behalf on what her opinion's no longer hold any weight. My appeal was submitted on March 12, 2015 according to Ms. Walker. I'm writing to inquire who has been appointed to my case. I can't understand how this happened to me and I just want to get a end to this. I just received my motion of Discovery and saw my counsel actually withheld information that could have definitely cleared the jury verdict. I had several adult witnesses; she convinced me no should only see her. She was in the courtroom, the prosecutor read around me. I wasn't next that day and I had my time card submitted into evidence. No finger prints, no gun, no car, no identification. The cops submitted no search warrants and allegedly I was the only suspect identified the day of the crime. So no merchandise was recovered, and over \$10,000 of electronics was stolen. I was contacted by law enforcement three weeks after the incident occurred. I was arrested and recommenced a investigation before I go up on bond. Never received one adult witness name or statement. I was given a \$35,000 surety bond in 2012. Since then I was a working citizen, a father, and fiance in school as before this crime occurred. In 2015 this happened. I was convicted off circumstantial evidence. The same two eye witnesses/victims that got on the stand and pointed at me as the one suspect of two items that committed the crime, one never wrote a statement to law enforcement or submitted to a trial and the other made several in which stated they were at the place of the crime first, then pulled up on another. I don't know how but I'm sure if I had three contradicting reports I would be found guilty in 2012. My life has been snatch from me before my eyes. It hurt me until now to pick my head up. I'm 28 years old, I had a criminal past, but nothing that would of led to this. I'm aware I may have explained too much but I wasn't sure what to say or not. I'm only giving two envelopes a month here and I sent them to my fiance upon my arrival to assure her I'm okay. The fact that I'm indigent has been taken for granted. I'm not perfect but I'm innocent! Please give this letter to whoever is can represent me. I'm now aware that alot of this information will have to be made known on my PCR. Due to the fact my lawyer made very little objections failing to preserve my right for a direct review. I need someone to help right now. Considering how the judge and solicitor seemed to be friends I have a feeling they are going to do their best at prolonging my appeal. Is there anything my family or I can do to have this matter brought back before the courts soon? Can you send me information on Court of Appeals law? Or anything on my trial's and amendment. I've lost two jobs since this occurred, my home, part of my family. I'm in debt, I suffered a great deal of humiliation and public discrimination. And all I asked for was justice considering the nature of crimes that has been afflied on the family of an old business partner. Now my family and children are victims to a much worst crime. Can someone please help me in a much quicker timely manner?
