court of Appeals I sent

with proof of service.  
I filed this motion to  
reconstruct and/or recon-  
sider from a 2001 hearing  
I had in which the courts  
abuse their discretion and  
conducted a hearing with-  
out a court reporter so  
there was no record  
of appeal that the appeal  
courts could review.  
There was an unpublished  
opinion by the court of  
appeals. The Attorney  
General's office stated  
in their brief that the  
only thing I was entitled  
to was a reconstruction  
hearing and not a new  
trial because the like  
of court reporter. No  
hearing has yet been

conducted so I filed a Motion  
to Reconstruct or Reconsider  
back in 2014 to the lower  
courts. It was stamped  
and filed by the clerk  
office. I finally got a  
letter in the mail from  
the administrative  
Judge John Steven in  
which I sent the court  
of Appeals in which he  
didn't sign the order  
of dismissal but another  
Judge Culbertson. There  
was no hearing held on  
this matter so there  
fore no transcript or  
a ruling or conclusion  
of law dismissing the  
Motion I filed so the  
courts are at error  
for such conduct.  
I just also got the  
letter from the

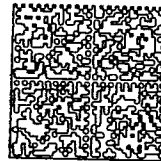
