

Daniel Jenkins in this Court, on March 3, 2015. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Willie Adams v. State with this Court, on March 2, 2015.

3. As indicated by his consent below, counsel for the state does not oppose this request.


