MOTION FOR AN EXTENSION OF TIME

previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel had an oral argument in the case of The State v. Demetrius Goodwin in the Supreme Court on February 18, 2015. Counsel filed the brief of appellant in the case of The State v. 5. Counsel for the Attorney General's office consents to this request shown by signature below.




