MOTION TO EXTEND TIME

Appellants Bay Island Sportswear and Sam Simchon, Individually, hereby move, pursuant to Rule 263(b), SCACR, to extend the time within which the Appellants must file and serve their initial brief and designations of matter to include in the Record on Appeal. The current deadline is April 15, 2015.

The Appellants request this further extension because they have moved to consolidate the within appeal with the pending appeal in *Vince Coates v Dorothy Renee Simchon*, Appellate Case No. 2014-002729. The briefing schedule in that appeal has been held in abeyance pending

the disposition of a motion to withdraw filed by counsel for the respondent therein. A similar motion to consolidate that appeal with the within appeal is also pending. The Appellants submit that efficiency would be better served by the Court consolidating these related appeals and directing the preparation of a single set of briefs and a single record on appeal. The Appellants therefore request a further extension of thirty days to allow additional time for the Court to act on the pending consolidation motions.

For these reasons, the Appellants respectfully request that the due date for their initial brief and designation of matter to be included in the Record on Appeal be extended to May 15, 2015.





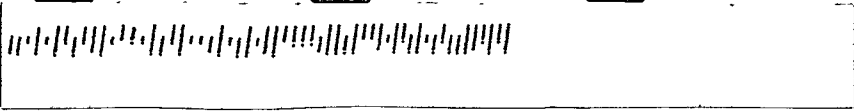
