Appellate case No. 2015-000650

- 1) Rule 201(b) **Who May Appeal**. “Only a party aggrieved by an order.....” which fits Appellant Tangeman
- 2) Rule 203 (1) **Appeals from the Court of Common Pleas**. “A party need not appeal until Receipt of written notice of entry of the more complete order or judgment”. Then, One has (30) Days within which to file the **Notice of Appeal**. In my email dated 01/28/2015 Appellant Tangeman clearly requested of Respondent Mr. Martens to send me a copy of said Order. 




