This citation is an order that grants summary judgment on and dismisses all claims brought by Hanneman and Morris for accounting, indemnity, conversion of HOA Funds, breach of fiduciary duty, and negligence against the Live Oak Homeowners Association, Plaintiffs and William McFarland.


This citation is pertinent to the "Worthless Check Investigation" discussed in both Appellant and Respondents' briefs, which involved the contested testimony and

evidence from Hanneman and Morris alleging that Mr. McFarland acted improperly with regard to his duties on the HOA Board, as well as the mischaracterization that Mr. McFarland was removed from the HOA Board.
