I. Please be advised, Appellants  
initial Notice of Appeal Dated September  
14, 2014 was missing a copy of the Order.

As of April 8, 2015, Judge  
Diane Goodstein has refused to provide  
a signed Order per The South Carolina  
Rules of Court Rule 59(C) and 58E

A) a copy of the final decision  
which is the subject of the Appeal and  
the date received.

B) The final Order or decision  
which is subject to administrative review;

II. Judge Diane Goodstein failure  
to produce a written Order as of January  
14, 2015 has resulted in Appellants Continued  
false imprisonment. Appellant's family has  
arranged for appellant to be bonded out  
of Jail in January 2015. However, NO  
Order exists for bondsman and Clerks office  
to execute Bond finalization.


IV Appellant Bond has been signed and paid. However, Appellant continues to be falsely incarcerated based on the lack of a signed order from Judge Goodstein.

V Judge Goodstein's failure to provide a written order to the Clerks Office, prohibits Appellants New Bond Company from obtaining the required approval from The Richmond County Clerks of Courts Office i.e. Criminal Record Section.


