

which time the defendant enter a guilty plea to his/her pending charge





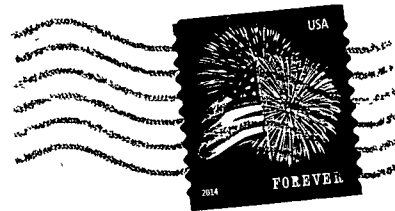
