
Dear Ms Kitchings:

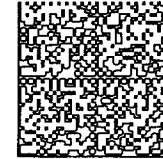
