





envelope?

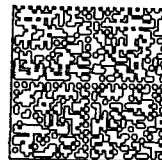
