

The Honorable Roger M. Young Sr. granted Respondent Branch Banking and Trust Company's ("BB&T's") motion to strike Appellant's jury trial demand on February 9, 2015. Skywaves I Corp ("Skywaves") filed a timely post-trial motion on February 18, 2015 pursuant to Rule 59(e), SCRPC and noticed its appeal March 10, 2015.
