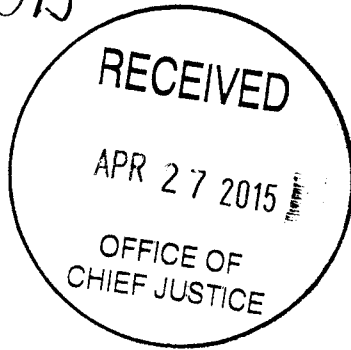

Dear Chief Justus Toall.  
 I am writing to you asking for your assistance and concerns of case matter within.  
 on June 17<sup>th</sup> 2014 I was sentenced to two (3) year sentences to run consecutive. The sentence was suspended to fourteen month teen challenge program By Honorable Steven H. John in Georgetown S.C. I was then ordered by the same court to report to Philadelphia PA. And I did so. There was no communication with S.C. and Philadelphia PA at all.  
 The court erred by handing down this sentences.  
 The courts of S.C. lost all jurisdiction when they order ~~me~~ for me out of the state of S.C.

To go

to do time in Philadelphia PA.  
The courts knew that this was an  
illegal sentence and still  
they ordered me out of state  
to do time. one would only  
think that the Chief Administrative  
Judge would have known that the  
sentences that he handed down to  
me was not legal but was illegal  
and unconstitutional.

The court failed in its duty to  
establish any continuing jurisdiction.  
By suspending the sentence and  
ordering me out of state to do  
time freed me of any and all  
litigation of S.C.

But the court went one step  
further with their conspiracy to  
have me illegally detained and  
deprived me of my liberty.  
I had not committed any new  
offenses in or out of S.C.  
I was not legally obligated or  
bound to the state of S.C.

Even after all of this one would think that there was a stopping point for this madness. But there was not!!

My sentence was suspended with no probation or fines or legal obligation to S.C. at all. So they dropped the ball and they were mad about it all and tried to fix it by more of their illegal doings with the good old Boy ~~System~~ that has worked for them so long.

So the Clerk of Court ordered and signed a bench warrant for my return to S.C. The warrant was not signed or authorized by a Judge at all. Well needless to say I was picked up out of state and sent back to S.C. Then forced under duress to appear pro se at my sentencing hearing. I was then given two (2) year sentences to run consecutive and was sent to prison.

I am being detained illegally and every day that pass is one that I can't get back.

To this day I am still without a lawyer. I am lost and in need of help. I have wrote the Sentencing Judge, Governor's office Clerk of the Appeals Courts (3 times) and still no correspondence at all from them. I have wrote to you all so and was told that my case was transferred to the Court of Appeals. But still no correspondence from them at all. I have not been appointed a lawyer as of yet. Can you help me? this Court is my only hope for justice. I am asking this Court to take jurisdiction of this case and matter!! After all of this I still have faith in our court system.

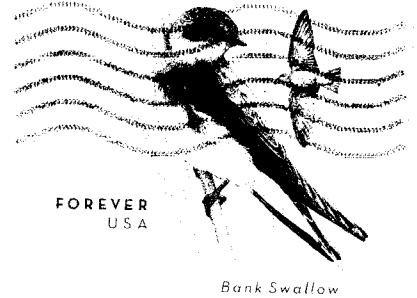
