

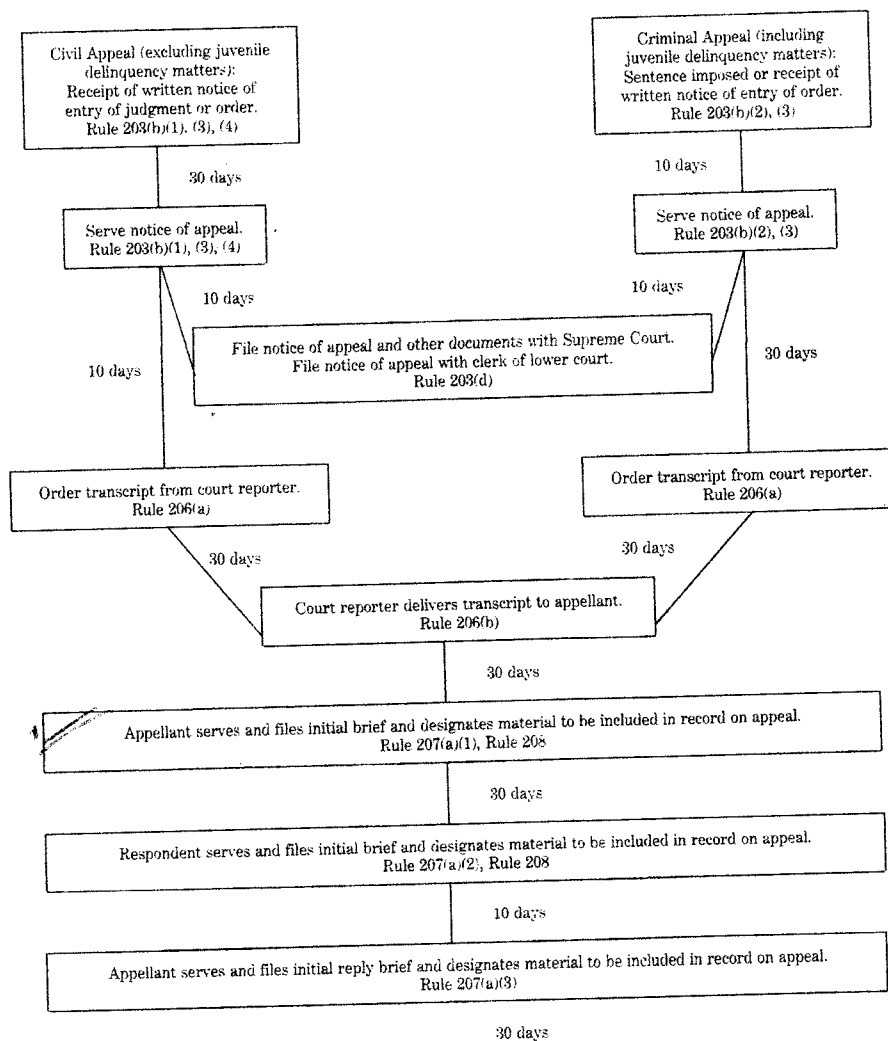

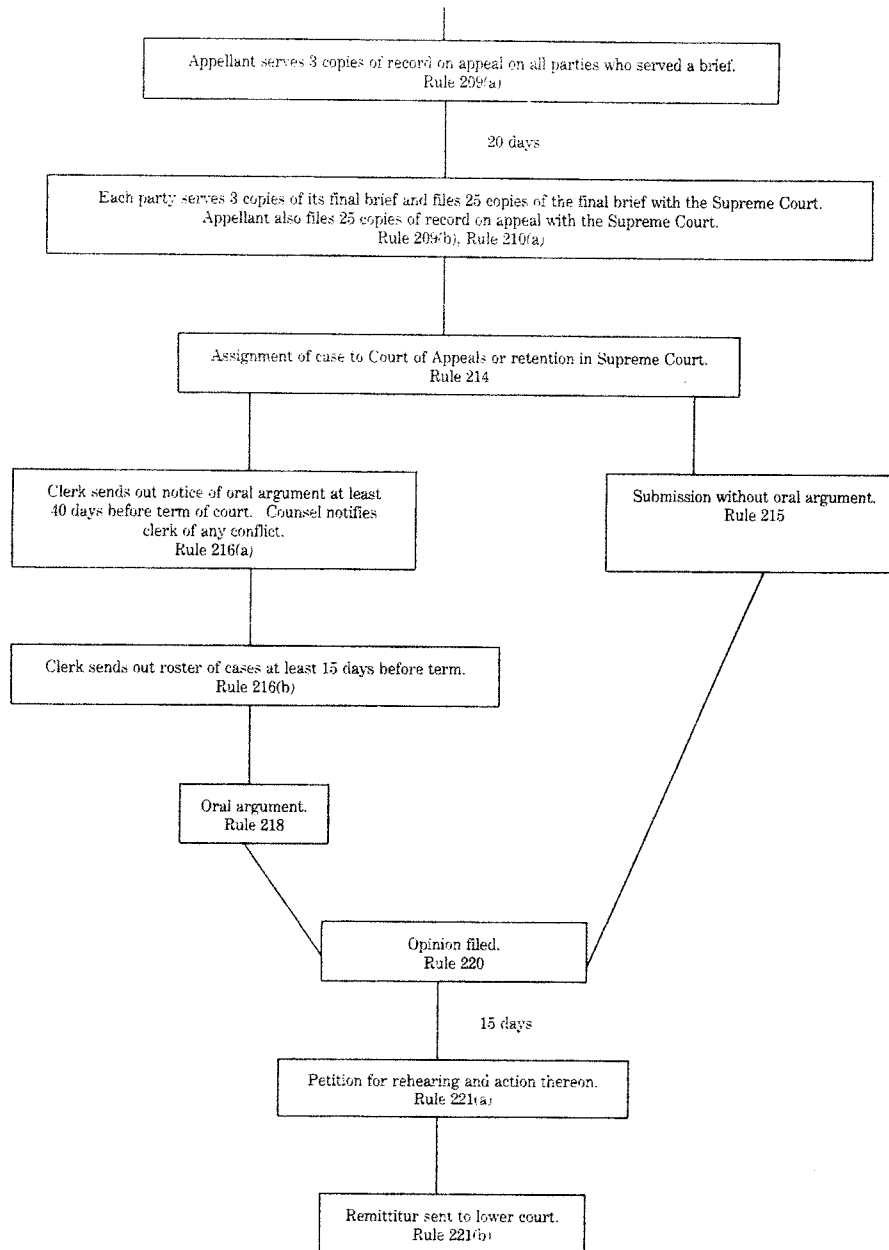

Therefore, according to the attached Appeals Chart, the Record on Appeal will be due 30 days from today. Please advise.


