




This case was tried before the Honorable Thomas Russo and a jury on September 30, 2014.

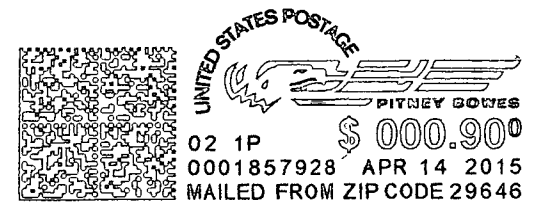
