Also as for the filing fee I will need the Formas Paupus form to fill out. Thank you so much for your time and help concerning this matter.

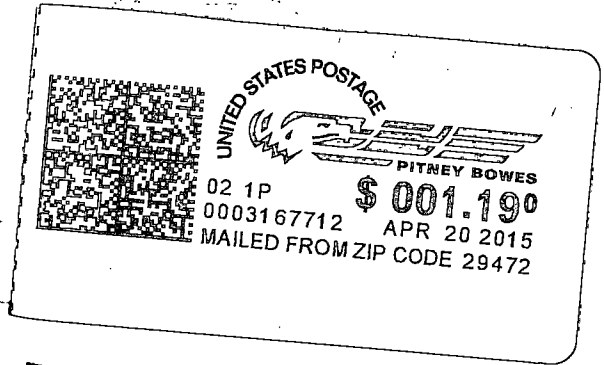
