
MOTION FOR EXTENSION

Pursuant to Rule 240, SCACR, the petitioner requests a 10-day extension of the deadline for filing and serving the reply brief. The current deadline is May 4, 2015.

The grounds for this request are that the petitioner's counsel does not expect to be able to complete a reply of the desired quality by the current deadline. See *RE: Extensions in Cases Seeking a Petition for a Writ of Certiorari to Review a Decision of the South Carolina Court of Appeals*, S.C. Sup. Ct. Order dated July 16, 2014 (Shearouse Adv. Sh. No. 28 at 1).

This will be the third extension request during the certiorari and briefing process. The petitioner requested a 5-day extension for filing the cert petition due to workload. The next request was for a 2-day extension for the cert reply due in part to the Thanksgiving holidays. The current request will not exceed the 20-day cap this Court's order establishes for extensions. The Order instructs that the 2-day extension is deemed to be a 5-day request. This leaves 10 days remaining.
