The said Oath of Office being your open and binding and irrevocable offer, to which my acceptance does hereby ratify into a firm and binding, private, bilateral contract between us, by which you agree to uphold the Supreme Law of the Land, also known as the Constitution of the united States of America, with the Bill of Rights, and to perform all of your duties as a PUBLIC SERVANT, and to uphold and to protect all of our rights, and by which we agree to receive the said, and the implied protections and provisions of that law, and of our rights, both as and of the services of your Office, as the valuable consideration passing between us that consummates the acceptance of the contract as it was offered.

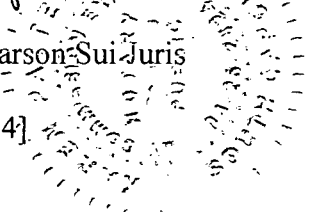
This, our Notice of Acceptance of your Oath of Office is made in good faith and explicitly without recourse. The contract now between us, now irrevocably


