
Response to Petition To Be Relieved As Counsel

Since attorney Douglas N. Truslow's involvement has, thus far, been detrimental to my family's legal affairs and this is the second time in 6 months that he has petitioned the court to be relieved as counsel, this may be to my benefit. As to the chain of events leading to this point, Truslow has not consulted with us, nor corresponded, with the exception of the recent notice, in nearly 6 months. His only prior correspondence was a copy of his proposed order on 9/26/11. He did not share with me Ms. Griffin's proposed order of 10/10/11 so I have no knowledge of any of his effort in the interim other than his desire to abandon us.

With the aid of Robert Dodsen, Esq. we failed to block Truslow's exit, January 18, from our other case. It appears a heated exchange he and I had prior to trial for this case, regarding the other matter, markedly prejudiced Truslow's prosecution of this matter.

History indicates my argument/opinion in this motion will be of little consequence. Therefore I have no objection to counsel's petition to be relieved.



I have been sternly forewarned that all can be lost in procedural confusion. I'm pretty sure this is improper procedure, but I find a proper procedure does not exist or, at least, is not readily apparent. My actions have so far been based on relative consequences. 
