**THIRD FORM 12**


On 3-5-15 I called Linda again and she contacted Deb Garrison and she stated she did not receive the letter from me On 3-7-15, I mailed a letter to her again

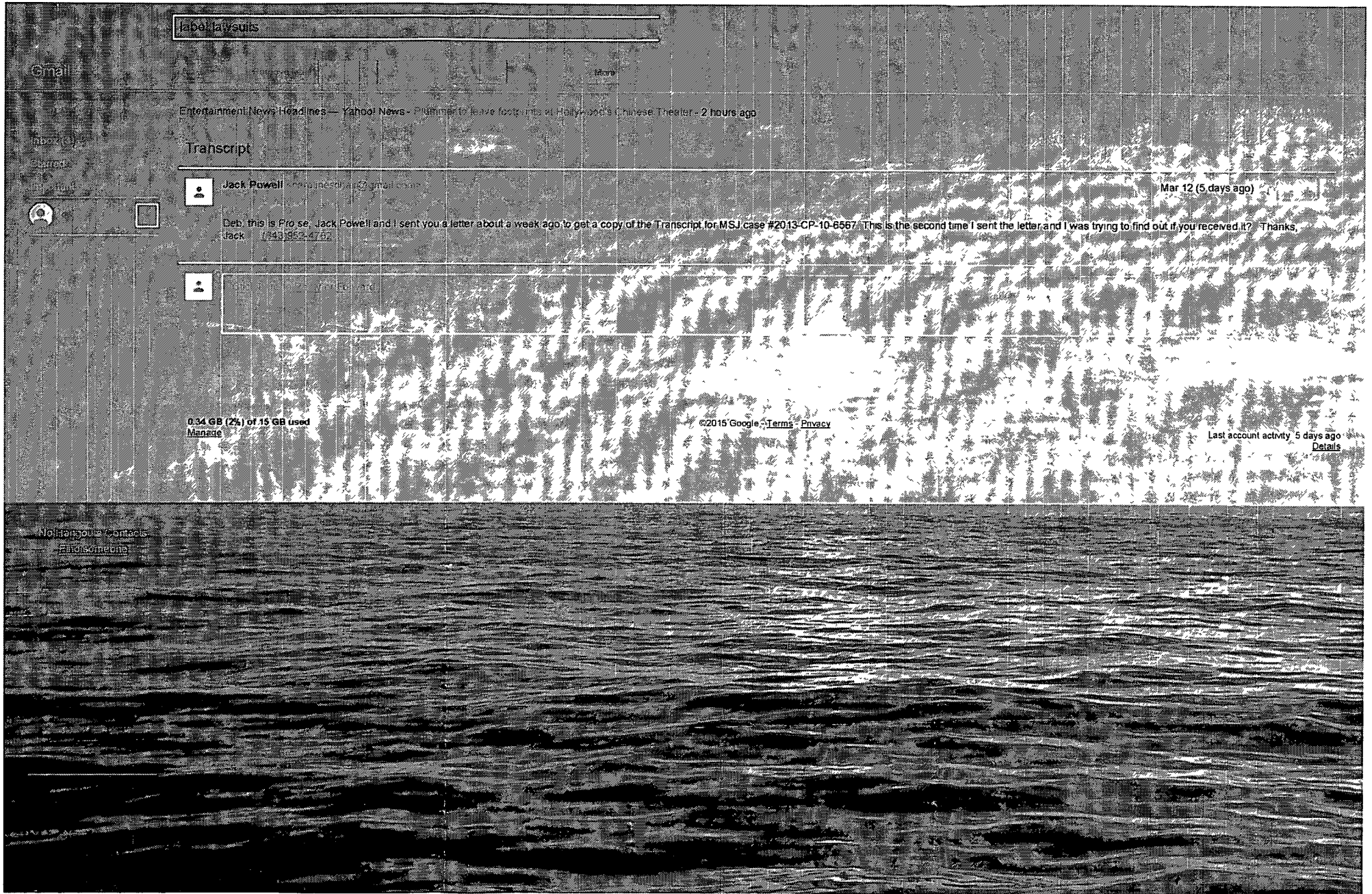
