I'm adding a 5th Form at the bottom which I consider an ongoing complaint of not cooperating with the legal process

1st FORM 12

I Pro se Appellant, Jack Powell contacted the Charleston County Clerks Office and Linda gave me the address of the Court Reporter to case 2014-CP-10-6567 which was Karen Anderson I wrote her a letter submitting my request for the transcript of the MSJ hearing held in the Judge R Markley Dennis Court and over a week later on 1-26-15 I received an e-mail from Karen stating she wasn't the reporter in this case

I called Linda again and explained about the wrong Reporter and she gave me the name and address to Deb Garrison I then called the Court of Appeals and explained this to Elizabeth and she tells me to send a letter explaining what had happened

The next day I received a letter stating "Our records reflect that the time for ordering the transcript has expired Within ten days of the date of this letter, you must file a copy of the letter showing that you have ordered the transcript from the court reporter,

along with a Motion and I called Elizabeth again and left a message about receiving the letter on Friday, four days after it was sent and I did not get a response from her on Monday either

SECOND FORM 12

On January 29th I mailed a request for the transcript to Deb Garrison and again I never received a call or letter

THIRD FORM 12

On 3-5-15 I called Linda again and she contacted Deb Garrison and she stated she did not receive the letter from me On 3-7-15, I mailed a letter to her again

FOURTH FORM 12

On March 17th 2015 I sent an e-mail to Deb Garrison inquiring if she had received my 2nd letter and e-mail requesting a Transcript because I hadn't heard anything from her, in over a week The next day on March 18th I received a letter from Deb Garrison stating, neither the name Jack Powell or Carolina Care ? is associated with any of those docketed cases She should have known of the case she was in court with on the date I had given her, Jack Powell v Carolina Center for Occupational Health, but I did make the mistake of submitting to her it was year 2014 instead of 2013 I have mailed her again on March 20-2015 another Form 11

FIFTH FORM 12

On March 27th I sent Deb Garrison an E-mail explaining I had sent her a letter over a week ago and I have not received a call or E-mail back and she E-mails me back on April 2nd and states she was assigned out of the circuit the past several weeks and was unable to pick up her mail And then she adds, Transcript request are not accepted via E-mail ,, What ????? I sent the LETTER request twice to the same address every time HER HOME PO box 90, Johns Island Now it's eleven days later and no response

Is there another process of obtaining the Transcript because this is the same manner I've been dealing with, beginning in Judge Dennis's court room ever since he insulted me and I filed a complaint
