I THEREFORE STATE THAT THE PLAINTIFF IS A RESIDENT OF THE SOUTH CAROLINA DEPARTMENT OF CORRECTIONS AND IS PRESENTLY AT PERRY CORRECTIONAL INSTITUTION IN PELZER, SOUTH CAROLINA, 29669.

FOR THE FOREGOING REASONS THE PLAINTIFF HAS FILED WITH THE EIGHTH CIRCUIT COURT A NOTICE OF APPEAL AND SENT COPIES TO ALL PARTIES OF THE SAME:

(1) THAT PLAINTIFF WAS ON LOCK UP AT THE TIME BEFORE AND DURING THE RESOLUTION FEE DISPUTE HEARING THAT WAS HELD ON SEPTEMBER 17, 2014 AND THAT HE COULD NOT OBTAIN CERTAIN DOCUMENTS OR AFFIDAVIT OF WITNESS CONCERNING FACTS OF DISPUTE. THAT PLAINTIFF COULD NOT USE A PHONE TO CONTACT OR OBTAIN CERTAIN NEEDED FACTS CONCERNING THIS FEE DISPUTE, AND HAS COPY OF LETTERS TO THE CHAIRMAN OF THE RESOLUTION FEE DISPUTE BOARD OF THE EIGHTH CIRCUIT CONCERNING THIS MATTER AND ASK FOR COUNSEL TO BE APPOINTED UNDER THE CIRCUMSTANCES OF BEING ON LOCK UP AND NOT ABLE TO GATHER THE NEEDED MATERIALS NOR PROPERLY REPRESENT HIMSELF.

(2) THAT MUCH NEEDED FACTUAL DOCUMENTS AND INFORMATION WAS NEEDED OUT OF PLAINTIFFS PROPERTY WHILE ON LOCK UP, THAT STEMMED FROM ALL THE FRUSTRATION DURING RETAINMENT AND CONTINUAL NON CORRESPONDENCE FROM ATTORNEY, AND THAT SUCH INFORMATION

HAS BEEN OBTAINED SINCE BEING RELEASED FROM LOCK-UP, PLUS OTHER FACTUAL EVIDENCE TO SUPPORT ALL CLAIMS OF FEE DISPUTE.

(3) THAT SUCH EVIDENCE AND DOCUMENTS WERE NOT KNOWN OR AVAILABLE TO PLAINTIFF AT THE TIME AND THROUGH DUE DILIGENCE AND FINALLY ABLE TO CORRESPOND WITH WITNESS, HAS NOT ONLY OBTAINED SUCH RECORDS, BUT WILL PRODUCE THEM ON PLAINTIFF'S BEHALF.

(4) THAT PLAINTIFF APPEALS THE FINAL DECISIONS OF THE RESOLUTION FEE DISPUTE BOARD CONCERNING STATEMENT OF NOT SPECIFYING A DETERMINED AMOUNT TO BE REFUNDED BECAUSE OF NOT UNDERSTANDING SUCH LEGAL MATTERS AND NOT BEING ABLE TO PROPERLY PREPARE, AS ALREADY STATED.

(5) THAT PLAINTIFF WAS RUSHED AND HAD VERY LIMITED RESOURCES TO TRY AND PREPARE FOR HEARING, AND COULD NOT GET MUCH NEEDED COPIES MADE OR DOCUMENTS NEEDED TO PRESENT AT HEARING AND FACTUALLY PROVE DISPUTED FUNDS PAID TO ATTORNEY TO REPRESENT HLM.
