
Please allow this letter to notify the South Carolina Court of Appeals of our firm's representation of the Solicitor of the 13<sup>th</sup> Judicial Circuit ("Solicitor") in the above-captioned case. It is my understanding that Appellant, Elephant, Inc., intends to file a petition for a writ of supersedeas ("Petition") in this matter.
