
Dear Ms.Kitchings:

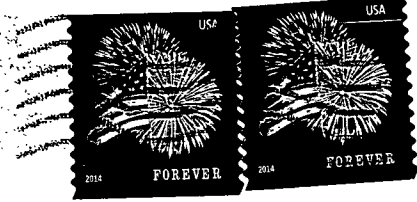
