

NOTICE OF APPEAL

MeadWestvaco appeals the order of the Honorable J.C. Nicholson, Jr., dated January 15, 2012, which reversed the final Decision and Order of the South Carolina Workers' Compensation Commission, made new findings of fact on appeal based upon conflicting evidence, addressed legal issues which were not properly preserved for review, and remanded the claim to the Workers' Compensation.

In addition, MeadWestvaco also appeals the October 11, 2013 Order of the Workers' Compensation Commission entered pursuant to Judge Nicholson's remand instructions and the Order of the Honorable Deadra L. Jefferson dated April 7, 2015 affirming the remand Order of the Commission and the prior Order of Judge Nicholson. MeadWestvaco received notice of Judge Jefferson's Order on April 10, 2015.

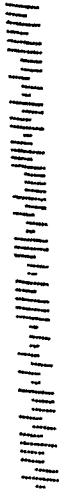

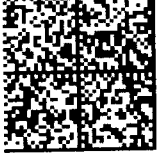
