**CONSENT MOTION OF APPELLANT
FOR LEAVE TO AMEND INITIAL BRIEF OF APPELLANT**

Appellant respectfully requests the Court's leave to amend Appellant's initial brief, to add more specificity to the citations to the Record on Appeal, as requested by Respondent. The amended brief was submitted to the Court on April 21. The changes are non-substantive, only to add specific citations requested by Respondent Counsel for Respondent has consented to this Motion.

Appellant filed and served its initial brief on April 1, 2015. On April 10, 2015, counsel for Respondent requested that additional specificity be provided for citations to the Record on Appeal. Two business days later (on April 14), Respondent provided the requested citations, in the form of an amended brief, to Respondent, by e-mail.¹ After receiving no indication of further concern, on April 21, 2015, Respondent sent formal copies of the brief to the Court of Appeals, with copies mailed and e-mailed to Respondent. The changes to the initial brief are solely the addition of certain citations to the Record on Appeal; there is no substantive change.

Appellant requests the Court's leave to file the amended initial brief on April 21, 2015, for the purpose of providing additional specificity in the citations to the Record on Appeal. Appellant has no objection, and consents, to a 30-day extension to Respondent's time to respond to its initial brief.

¹ This request involves three similar appeals in which the Callawassie Island Members Club is the Respondent: 2015-000001 (*Martin*), 2015-000002 (*Frey*), 2015-000003 (*Quinn*). The citations in the three initial briefs are almost all the same. The citations provided on April 14 were to the initial brief in appeal 2015-000003 (*Quinn*). Upon receiving no objection or concern from Respondent about the *Quinn* updated citations, Appellant updated the other two briefs (*Martin* and *Frey*) and on April 21 formally served them upon Respondent and submitted them to this Court.


