
Dear Ms. Kitchings:

Please find my response to courts request of the status of transcript in dated April 22, 2015. I am submitting this response in compliance with the SC Judicial department Rule 263(a), in that the final day to respond to the courts request fell on Saturday, May 2, 2015. Rule 263(a) allows for the response to be filed on Monday, May 4, 2015.

I have delayed the submittal of the transcript of the trial to the South Carolina Court of pending the court's decision on the appellants counsel's motion to withdraw as counsel for two reasons. 


