

Counsel filed the amended brief of petitioner in the case of Lenson Clyburn, Jr. v. State in this Court on March 4, 2015. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Gerline Pressley v. State in this Court on March 4, 2015. Counsel filed the brief of petitioner in the case of State v. Kevin Jerome Gilliard in this Court on February 13, 2015.

3. This request is made in good faith, and not for purposes of delay. Counsel is striving to limit the number of extensions requested. Counsel is attempting to complete the cases with the most number of extensions first.

4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.


