Defendant Lucius Fowler appeals his conviction and sentence in this case. The defendant pled guilty to Assault and Battery 1st, Attempted Murder (x2) and Burglary 2nd Violent, and was sentenced to ten (10) years, two terms of twenty (20) years, and a term of fifteen (15) years, respectively, to be served concurrently on May 4, 2015.

The issue for appeal is that during the guilty plea, the charges were not properly articulated to the Court, and the Plea was not knowingly and voluntarily made.


