Please accept this letter and the following as my compliance with Rule 203(d)(1)(B)(iv) requirement for a written explanation showing issue to be reviewed on appeal.

Mr. Wright moved for myself, Steven L. Alexander, as his appointed counsel to be relieved of representing him after his case had been placed on the trial docket as well as for a continuance from of his case from that term of court's trial docket so that he could have time to retained private counsel. 
