

## VOIR DIRE

1 Cherokee, State of South Carolina on or about January 12th  
2 of 2012 that the defendant did commit the offense of assault

14 oath at this time. The first question, has anyone ever been  
15 related by blood or marriage to Mr. Kenneth Gerald Butler or  
16 Matthew Brandon Holcomb? Anybody related by blood or  
17 marriage to either of those individuals? Has anyone ever  
18 had a close, personal or social relationship with either of  
19 those individuals? If so, please stand. The following is a  
20 list of possible witnesses in this case, and when I tell you  
21 possible they are possible. I have no knowledge of whether  
22 or not they will be called but I'm going to read the list  
23 that had been given to us. Kenneth Butler, David Bratton.  
24 Triston Austin. Kelly Stanford. Phillip Willoquy,  
25 (phonetically) Spartanburg County Sheriff's Department.
