

NOTICE OF APPEAL

Foothills Anesthesia Consultants, P.C. and Adam D. Evec, D.O. appeal the May 8, 2015 Order of the Honorable Roger L. Couch, denying their Rule 42 motion to consolidate for trial the above-referenced case—a loss of consortium action—and a closely related case—a medical malpractice action on behalf of her husband, Jerry Dale Simmons. These two actions involve many common questions of law and fact. In fact, 19 out of the 22 paragraphs of each Amended Complaint are identical. The two Amended Complaints contain identical allegations of negligence on the part of the defendants. Appellants received notice of Judge Couch’s Order on May 8, 2015 but have not yet received a written order.




