I am respectfully writing you in reply of your letter that I have received from your office from the mail room here at KCI 7-11-2014 its post marked July 7TH 2014 but I did not get this letter that day I received it 7-11-2014 it says I have 20 days from July 2ND 2014 due to me being incarcerated I am trying to meet the deadline my argument is I did not get the plea that I signed and I did not understand the sentence I got, until after court my attorney told me I got two years instead of ① and 4 years probation ① year to run consecutive with ① year I did not understand the plea and my public defender, Mr Brian Horrocks should testify on my behalf he knows I did not know I got 2 years instead of ① year, he fail to pull me to the side and to tell me what was going on legally, my attorney Brian Horrocks with the public defender's office Bar # 101043 fail to explain my rights and I do not know my legal rights of and appeal... I signed a plea to go in front of the honorable circuit court judge McCaulley but I didn't until a few days later I went in front of G. Edward Welmaker I felt I was pushed into situation unethically from the start... I have a disability to which is recognized by the state of South Carolina and the government which I have drawn a check for years. I have trouble understanding and I am uneducated for reasons my argument is I did not understand the plea I signed a ① year plea and I got ② years ① year to run consecutive with ① year I am asking the courts to run the two ① year sentences concurrent and disperse of the probation, I do not know my legal rights and I stated in the transcript I did not get much legal advice from my attorney I asked him repeatedly to come talk to me and he did not know nothing on my case until he came to me with the ① year offer from the solicitors office which I did not get... That's my argument and I still have not gotten any legal advice for the appeal

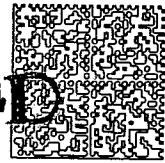
