



ORDER



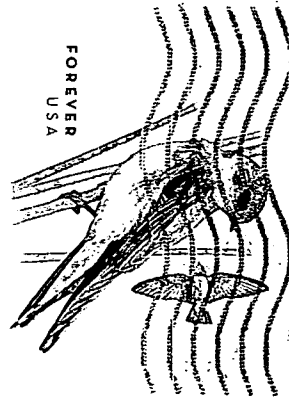
