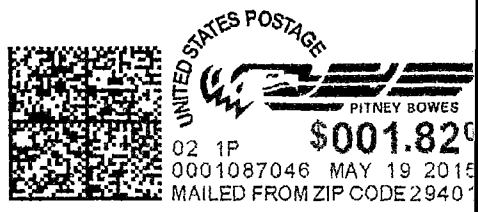
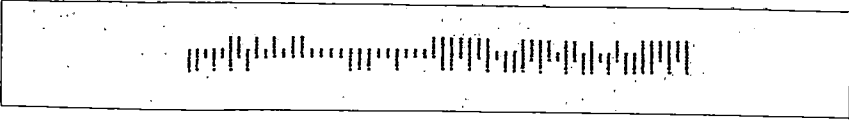
In addition I have enclosed a copy of the Notice of Appeal evidencing receipt by the Clerk on May 12, 2015.
