
Due to the fact that I filed Motion to Reconsider Sentence on September 26, 2014, I had instructed my office staff to not file the standard Appeal. Apparently the Appeal was inadvertently filed on my behalf.

I have enclosed a copy of the filed Motion to Reconsider regarding this matter. As you can see from the language of the Motion, I have strategically asked that the Motion not be heard until the co-defendants are sentenced. As of now, one co-defendant sentence still remains pending. Due to this motion still being unresolved and unheard, it is my understanding that the Appeal is not ripe at this time and it tolls the time for the filing of this appeal.

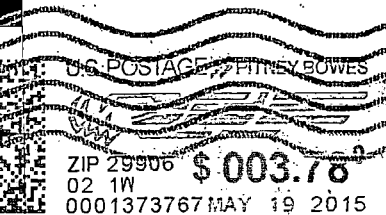
