Dear Mr. Strom:

I received your Correspondence in regards to my letter Dated: April 9, 2015.

I have expressed my concerns, and issues in regards to the "direct verdict" and "Alleged Amendment" of Charges. I trust and believe you would do your best to find reversible error.

I would like to request that you submit the transcript of record with your "Submitted Brief," because the acts of a courts records are known by its records alone, and cannot be established by Parol testimony. The court speaks only through its records, and this rule applies in case of a Judge." Further more, the records of a Court cannot be impunged upon matters within, its Jurisdiction when offered in evidence by Counter evidence.

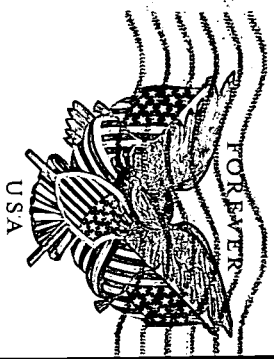

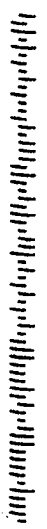
