In writing to agree my case Appellate case No. 2014-002163. In the transcript my attorney admits that he knows it was a trap, what is discussed behind closed doors is not recorded in this because it was between my attorney and me. It also says he can't recall sending me a letter or letting me know about my trial (page 41) He never let me know about anything. I found out after I was taken to Georgetown county courthouse on Oct 24, 2012 that I was going to trial. I couldn't talk to my family, my witnesses, I was blind and I trusted Mr Frederick and it backfired on me. I was under the impression that he would handle all of this. Also on page 40 question 5-7 Mr Frederick says he does not know which judge granted his relief. It was the same judge that sentenced me to the 4 year sentence Judge Cottingham. Then Judge Cottingham arraigned me again after that with Mr Ronald Hazard my state appointed lawyer. On pages 39 question ~~12~~ 13 and 14 Bobby Frederick admits that he knows it was a trap. He never told me anything about nothing

being a trap. All I want is a resolution to these charges. There was never a burglary 1st charge to begin with. The date the burglary was supposed to occur was on Oct 24, 2010. The 911 call did not happen to Oct 25, 2010. (The next day) That puts it as a burglary 2nd there automatically. I am serving a 15 year sentence now on the same charges. I had to bond out on the charge I went to prison on on Oct 24, 2012. I bonded out on that same charge Aug 5, 2013. All records at Georgetown County and the ones I got show I bonded out on that charge after it was supposed to be finished with. I just want the 10 year sentence that the max for Burglary 2nd charges. I don't want to go home, I just want the max and be done with all the charges. I was charged with all these burglaries at the same time in 2010. I'm having to do a 4 year sentence and a 15 year sentence on burglaries that happened within 30 days of each other. Please consider my plea I've been going through this since Dec. 2010. I've

lost ^{to} 7,500⁰⁰ cash plus countless calls and letters to my attorneys and courts. I really think 10 years is fair with all these charges. They were all rental beach houses and most of them didn't have any evidence. I am guilty of being around the wrong people and associating with other criminals. Please grant my request so I can finally wrap this up. The ~~US~~ courts and myself have spent enough time on all of this already. Thank you and I look forward to hearing your decision.

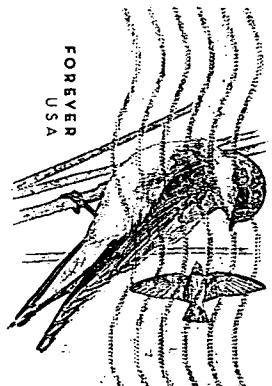

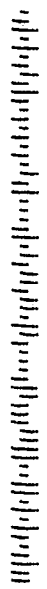
