2. Please be advised that I have four (4) pending Appeals in your office three (3) ARE AGAINST the S.C.D.C.





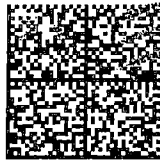
