Thank you for your letter of May 13, 2015 regarding the above-referenced appeal. You have requested a copy of the order referenced in the Notice of Appeal with the lower court case number 2013-CP-10-6723 challenged on appeal; however, I enclosed copies of all of the orders being challenged on appeal with our Notice of Appeal.

Following a remand order by Judge Nicholson dated January 14, 2013 in case number 2010-CP-10-6041, the Workers' Compensation Commission issued an order dated October 11, 2013. This October 11, 2013 Commission order was then appealed to the Court of Common Pleas on November 12, 2013, at which time the Court of Common Pleas assigned case number 2013-CP-10-6723 (see attached). The notice of the hearing before Judge Jefferson on January 8, 2015 also employs the case number 2013-CP-10-6723. Unfortunately, the order disposing of case number 2013-CP-10-6723 was drafted by the Steinberg Law Firm and bears the wrong case number; specifically, the case number from the prior appeal heard by Judge Nicholson: 2010-CP-10-6041. Therefore, there is no order bearing the 2013-CP-10-6723 case number; however, because this case number is referenced throughout the record, it was included in our Notice of Appeal to the Court of Appeals.

With regard to proof of service of the Notice of Appeal on the Workers' Compensation Commission, I have enclosed a copy of the same showing that the Commission was served with a copy of the Notice of Appeal on May 6, 2015.
